Supervisor Todd Campbell called the Town Board meeting to order at 7:00pm

### Resolution # 68 - Minutes

Supervisor Campbell asked for a resolution to approve the June 14, 2023, Town Board Meeting Minutes. Councilman Travis made the resolution to approve minutes seconded by Councilman Carey. Adopted: Ayes – Campbell, Carey, Travis, Harman, DeSanctis, - Nays, None Resolves that the June 14, 2023, minutes are accepted/approved as presented.

#### **Resolution #69 - Supervisor Report**

The Supervisor's Report dated July 11, 2023, was distributed, and discussed. Supervisor Campbell asked for a resolution to approve the submitted Supervisor report. Councilman Harman made the resolution to approve the Supervisor's report, seconded by Councilman DeSanctis.

#### Resolution #70 – Justice Report

#### Resolution # 71 Vouchers – Payment of Bills

Supervisor Campbell asked for a resolution to approve the payment of bills on Abstract 7 for 2023 for General and Highway.

Councilman Harman made the resolution to approve the bills/vouchers as presented, seconded by Councilman DeSanctis.

#### Resolution #72 – Highway Report

Highway Superintendent Ball submitted the Highway report dated July 12, 2023.

Supervisor Campbell asked for a resolution to approve the Highway Report.

Councilman Travis made the resolution to approve the July 12, 2023, Highway report, seconded by Councilman Carey.

Highway Superintendent Ball also discussed.

- Truck Purchases looking at available options. Estimating \$220,000.00 to replace 3 trucks, (1 1 ton & 2 250). The Board discussed the number of trucks to purchase/order this year in comparison to purchasing over multiple years. Further review and determination by the Board will be based on the options and data provide by Highway Superintendent Ball.
- Provided an update that a 2<sup>nd</sup> dumpster has been added to the Transfer Station

#### Resolution #73 Code Enforcement -

The May Code Enforcement Report was distributed. Supervisor Campbell asked for a resolution to approve the submitted Code Enforcement report. Councilman DeSanctis made the resolution to approve the June 2023 Code Enforcement Report seconded by Councilman Harman.

Resolves that the June 2023 Code Enforcement Report is approved as presented.

**Councilman DeSanctis** – initiated a general discussion and had several questions on the mowing of the roadsides and ditches. He asked about what can be done with regards to invasive grasses and weeds. Highway Superintended Ball answered the general questions and reminded the Board that Highway is not authorized to provide any spraying services.

**Councilman Carey** – inquired on the cost of the Community Focus. Mike Borgeest provided information on the cost and the quoting process as well as the services being provided. Supervisor Campbell commented that Community Focus is a main informational forum for the Town.

**Councilman Travis –** commented that the Town Hall parking lot should be paved. Highway Superintendent Ball was asked to provide a quote on the project for the Board.
