MINUTES

Town of West Bloomfield - Board Meeting

September 13, 2023 | 7:00pm

Supervisor Todd Campbell called the Town Board meeting to order at 7:00pm

Resolution #82 - Minutes

Supervisor Campbell asked for a resolution to approve the August 9, 2023, Town Board Meeting Minutes. Councilman Travis made the resolution to approve minutes seconded by Councilman Harman Adopted: Ayes – Campbell, Carey, Travis, Harman, DeSanctis - Nays, None Resolves that the August 9, 2023, minutes are accepted/approved as presented.

Privilege of the Floor

- <u>Deb & Steve Holdsworth</u> Spoke on the issue of increased truck traffic and excessive speed on Route 5 & 20 in the Town section with the current speed limit of 40 MPH. They also noted that traffic has been observed passing stopped school buses in that area that have lights flashing. They made the request that the Town review the option of having the speed limit reduced to 35 MPH, the State would need to review the speed limit reduction request. Supervisor Campbell is going to put in a request to the Sheriff's Department for increased speed control in the area, he is also going to contact the Bloomfield Central School regarding the issue of traffic passing stopped school buses in that area. Supervisor Campbell to provide follow up after contacting the Sheriff, State and School.
- <u>Mike Borgeest</u> Addressed the issue of the Code Enforcement position/office for the Town and the lack of consistent dedicated personnel is becoming a major concern. He also advised the Board of the issue at the Dollar General Store in Town having propane tanks in front of the store with no barrier.

Resolution #83- Supervisor Report

The Supervisor's Report dated September 9, 2023, was distributed, and discussed. Supervisor Campbell asked for a resolution to approve the submitted Supervisor report. Councilman Harman made the resolution to approve the Supervisor's report, seconded by Councilman DeSanctis.

Resolution #86– Highway Report

Highway Superintendent Ball submitted the Highway report dated September 13, 2023.

Supervisor Campbell asked for a resolution to approve the Highway Report.

Councilman Travis made the resolution to approve the August/September 2023, Highway report, seconded by Councilman Carey.

Highway Superintendent Ball also discussed.

• Truck Purchases – Issues with securing pricing and availability – Board advised Superintendent Ball to keep the current truck on order.

Resolution #87- 284 Agreement

Highway Superintendent Ball submitted an update on the 284 Agreement, original \$141,685 increase in CHIP Funds of \$11,371. Proposed using the increase in funds for wedging on Sand Road. Supervisor Campbell asked for a Resolution to amend the 284 Agreement to allocate these increased funds and update the current 284 Agreement.

Councilman Harman made the resolution to approve the 284 Agreement Update as presented, seconded by Councilman Travis.

Resolves that the 284 Agreement is Updated as presented.

Resolution #88– Truck Purchase

Highway Superintendent Ball advised a Volvo has become available for Truck 6 purchase. Delivery would be Q1 or Q2 of 2024.

Supervisor Campbell asked for a Resolution to authorize the purchase for the Volvo truck, price not to exceed \$325,000.00.

Councilman Harman made the resolution to approve the truck purchase as presented, seconded by Councilman Travis.

Resolves that Highway Superintendent Ball is approved to purchase the Volvo truck for a cost not to exceed \$325,000.00.

Code Enforcement Update

No Report Submitted. Supervisor Campbell provided an update that Jim Kier from Ontario County is working through the current backlog in the Code Office.

2024 Budget – Budget workshops to be scheduled for Wednesday September 27th @ 6:30pm. Supervisor Campbell is working on the Budget; DA was sent to Highway Superintendent Ball. No large growth is projected for Sales Tax, reviewing the tax rate for the Town. Salary increases need to be reviewed.
