MINUTES

Town of West Bloomfield - Board Meeting

October 11, 2023 | 7:00pm

Present – Supervisor Todd Campbell, Council-members- Bill Travis, Kevin Carey, Scott Harman. Absent: Bob DeSanctis. Also, Present – Town Clerk Brenda Giglia, Highway Superintendent Jeff Ball, Deb Holdsworth, Steve Holdsworth, Dorothy Graziano.

Supervisor Todd Campbell called the Town Board meeting to order at 7:00pm

Resolution #90 - Minutes

Supervisor Campbell asked for a resolution to approve the September 13, 2023, Town Board Meeting Minutes. Councilman Travis made the resolution to approve minutes seconded by Councilman Harman Adopted: Ayes – Campbell, Carey, Travis, Harman, - Nays, None Resolves that the September 13, 2023, minutes are accepted/approved as presented.

Privilege of the Floor

- <u>Dorothy Graziano provided a presentation on the Allen's Hill Library, including an overview of the services the library provides, and the upgrades/repairs the library is in need of. The 2024 Budget for the library was submitted to the Town Board.</u>
- <u>Deb & Steve Holdsworth</u> Inquired on the status of the review being done on the increased truck traffic and excessive speed on Route 5 & 20 in the Town section with the current speed limit of 40 MPH. Supervisor Campbell provided updates.
 - o The Sheriff's Department has been contacted and a request to increase traffic monitoring presence has been submitted.
 - o No updates on the issue of passing School buses. Resource Officer for the School is going to schedule following the bus runs to observe.
 - Temporary digital speed sign has been requested from the County/Sherriff
- They also brought up the issue of people using the Michael Prouty Memorial Park after dark and the damage that is being caused by reckless driving in the parking lot and road in front of the park entrance. They requested the review of adding lighting around the park/pavilion to help deter these actions. They have in the past addressed these issues by contacting the police department, they felt this did not provide much help in discouraging or fixing the issue.
- Highway Superintendent Ball to look into options for installing the lighting. He also mentioned that
 adding gates to close off the access to the pavilion area with vehicles at the end of the season would
 be beneficial.
